

### *IFLA Code of Ethics for Librarians in its final stages*

In almost 70 countries national library associations have worked out a national Code of Ethics for Librarians. Although archivists and museum specialists do have international codes of ethics for their professions IFLA and librarians don't have an ethical code on an international level yet.

This is one of the reasons why FAIFE took the decision to task a working group with drafting such an international code of ethics for librarians. The working group consisted of 5 members from 5 countries who are with one exception members of the FAIFE committee: Loida Garcia-Febo, Anna Hustad, Hermann Roesch, Paul Sturges and Amélie Valloton. The work started in summer 2010 and was kindly supported by Globethics who among others provided their expertise and work space on their online platform.

The paragraphs in detail were drafted by members of the working group in consultation with other experts. A first completed draft was discussed by the

working group and further experts at full-time meetings in The Hague (April 2011) and San Juan, Puerto Rico (August 2011). This resulted in a second draft in September 2011 which was distributed to further experts. In December 2011 Paul Sturges and Hermann Roesch had the task to review the comments that had been made in the meantime and to produce a third draft in a meeting at Cologne.

This draft was distributed and broadly discussed via IFLA-L and different national discussion lists of librarians. Hundreds of comments had to be discussed and to be taken into account. This process led to the latest version which now consists of the following parts:

#### Preamble

1. Access to information
2. Responsibilities towards individuals and society
3. Privacy, Secrecy and Transparency
4. Open Access and Intellectual Property

5. Neutrality, Personal Integrity and Professional Skills
6. Colleague and Employer/Employee Relationship.

IFLA's Governing Board has endorsed the main features of the draft in spring 2012 and amongst others suggested to present

the International Code of Ethics for Librarians a two pages short version as well. After this additional work has been done, it is now up to the GB to adopt the Code (and its two versions) and to present it the public at the WLIC in Helsinki

***FAIFE Books Club begins discussion of Ray Bradbury's  
"Fahrenheit 451"***

I'd like to invite all readers of this newsletter to visit <http://faifebookclub.ala.org>. That's the new interactive home of the FAIFE Book Club – an avenue for librarians and free expression supporters to discuss the issues raised by various books chosen by the FAIFE Committee. The current selection is Ray Bradbury's classic Fahrenheit 451. First published in 1953, Fahrenheit 451 has been translated into at least 33 languages, and is now available as an e-book as well.

While the book was chosen before Bradbury's 5 June 2012 death, the selection has proved to be a wonderful way to honor Bradbury's life as well as discuss many of the book's themes, which are as timely as ever today. State-mandated censorship, the role of media and technology in shaping our existence, and the status of literature in society are all great discussion topics.

The first selection of the FAIFE Book Club was Evgeny Morozov's The Net Delusion. We have posted 11 chapter-by-chapter analyses on the Book Club site (originally posted at LibraryThing), and even a Finnish translation of the chapter overviews and discussion questions!

In addition to the website, FAIFE Book Club discussion is taking place via an email list and a Twitter feed, and participants are welcome to post their thoughts on FAIFE's Facebook page. Following the FAIFE meetings in Helsinki, look for announcements about webinars, international Skype discussions, and in-person activities.

The FAIFE Book Club is cosponsored by the American Library Association Office for Intellectual Freedom. In addition, we are pleased to announce ALA's Intellectual Freedom Round Table as our first partnering organization.
