Statement of principles

WG2 identified, discussed and AGREED to the following Corporate bodies related sections in the Draft ICP (April 3, 2006)

- Paragraph 2 of Section 5.1.1.1
- Section 5.1.2.1.2
- Section 5.4 (incl. 5.4.1, 5.4.1.1, and 5.4.1.2)

WG2 Opinion One on Draft ICP (April 3, 2006)

- Addition to 7.1.2.2 (Indispensable access points for authority records)
- "If the term "variant forms" in second item of 7.1.2.2 does not include "cross-references", then it is suggested to add a 3rd item, "related forms of name (or title) for the entity."
- Note that members do not have a consensus on: (1) if the term variant form includes "related forms"; (2) whether to add the term (or title) in the statement.

WG2 Opinion Two on Draft ICP (April 3, 2006)

- The heading for section 5.1.1. Choice of Access
 Point
- Members of WG2 discussed the appropriateness of the term "choice" for the content and suggestion was given to use "scope". The group did not reach consensus on the amendment. However, the WG2 agreed to report this in the Report Section for the purpose of sharing the view.

WG2 Opinion Three on Draft ICP (April 3, 2006)

- To move "the year(s) of publication or issuance from section 7.1.2.1 to 7.1.3 as one of the listed attributes.
- Reasons:
 - To align with section 3.1.2 ...in which publication date is defined as other criteria
 - Publication year is rarely used as a major access point in OPAC searching
 - Users usually search by other major access points, such as author, title.

WG2 Opinion Four – minor amendments

- Draft ICP footnote 1, line 4, the publication year of PP should be 1961
- Glossary term: Bibliographic record .. {Source: ISBD(CR)] should read [Source: ISBD(CR)]
- Members would like to seek a clarification on the use of semi-colon; for the Glossary Term "Attributes" (see the Glossary)
