PREFACE

IFLA celebrated its 75th anniversary during 2002. Founded in 1927 during an international conference in Edinburgh, Scotland, it returned to Scotland, but this time in Glasgow, for its birthday. The highest ever attendance at an IFLA conference was recorded – a fitting achievement and strong evidence that the organisation is in good shape in the early years of the twenty-first century.

Following the tragic events in the USA in September 2001, our core belief in free access to information and freedom of expression were under severe pressure. In response to this, Council adopted the IFLA *Internet Manifesto* which asserts that “the provision of unhindered access to the Internet by libraries and information services supports communities and individuals to attain freedom, prosperity and development”. Council also adopted the IFLA *Glasgow Declaration on Libraries, Information Services and Intellectual Freedom* which proclaims “the fundamental right of human beings both to access and to express information without restriction”.

As part of the continuing reorganisation of IFLA’s structure following acceptance of the recommendations of the Warren Horton Report, most of the former Round Tables were translated into Sections. Funding of the Core Activities continued to be a challenge in 2002. We were, however, able to secure the future of our website IFLANET (formerly part of the UDT core activity), thanks to the generous offer of INIST in France to succeed the National Library of Canada in this role. The withdrawal, at short notice, of support by DANIDA the Danish development agency to the ALP and FAIFE core activities was a severe blow which significantly curtailed their work. We need to find ways of replacing the significant sums involved from alternative sources. The UAP core activity, hosted for many years by the British Library closed down and at the end of the year arrangements were in hand to ensure the continuation of the international interlending voucher scheme.

Our annual conference is, of course, our flagship operation. Two significant developments were in train during the year. The Governing board appointed Congrex Holland as the core professional conference organiser for a five-year period, beginning with the conference in 2005. This will ensure greater consistency and smoother management. The Professional Committee and the Conference Planning Committee were reviewing the structure of the event with a view to making it shorter with greater professional coherence.

As this report shows our anniversary year has been marked by a number of significant achievements to strengthen both the Federation and the world-wide library and information profession.

INTRODUCTION

This annual report covers the period of the calendar year 2002. IFLA had been founded in Edinburgh in 1927, the Federation fittingly returned to Scotland to celebrate its 75th anniversary during its 68th General Conference and Council meeting in Glasgow, UK (August 2002).

This report reflects only the major activities during the period under review. Fuller reports on the activities of IFLA's professional units can be found in the reports of the Core Activities and Sections on IFLA's website IFLANET <http://www.ifla.org/act-serv.htm>.

MEMBERSHIP

Although the first members were enrolled in the newly created categories of members: sub-units of Institutional Members (8), One-Person Library and Information Centres (2) and School Libraries (1), the total number of IFLA's membership decreased slightly during this reporting period.

As of 31 December 2002, IFLA had a total of 1725 associations, institutions, persons and corporations (from 152 countries) in membership. A specification of the total number can be found in Annex 1.

The working group to devise models for the revision of association membership fees, which had been established in 2001, continued its activities.

A complete overview of the Governing Board membership, including its committees, is provided in Annex 3.

COUNCIL MEETING, GLASGOW

The IFLA Council held its meeting on 18 and 23 August. After words of welcome from President Christine Deschamps, Ian McGowan, co-chair, reported on behalf of the UK National Organising Committee that the conference attendance figures were again to break records and congratulated IFLA on the occasion of its 75th anniversary.

Secretary General Ross Shimmon concluded that the Federation was in a healthy state, but as always more members were very welcome.

Council adopted several resolutions, two of which contained important statements: *The Glasgow Declaration* and *The IFLA Internet Manifesto*.

GOVERNANCE

Professional Committee

During the report period, the Professional Committee (PC) met on 25 and 27 March, (The Hague), 16 August (Glasgow) and 12 and 13 December (The Hague).

Apart from a large number of items regarding the administrative part of the professional structure (financial allocations, project management), the main issues on the agenda of the PC throughout the year were the transition of the

former Round Tables into Sections and the revision of the schedule for the professional programme for the annual congress.

The Governing Board and its committees

During the report period IFLA's Governing Board (GB) held meetings on 27 and 28 March (The Hague), 16 and 24 August (Glasgow) and 14 December. During the same weeks most of the committees that had been installed in 2001 also held their meetings; an overview of these entities is provided in Appendix 3.

As of the beginning of 2002 the transfer from the Dutch Guilder to the Euro took place; IFLA's administration and accounts followed this transfer. An overview of the consolidated accounts for 2002 is included as Appendix 2.

On the recommendation of the Professional Committee, the Governing Board approved the translation of the Genealogy and Local History Discussion Group into the Genealogy and Local History Section.

Following a recommendation by the Professional Committee in 2001, the Governing Board decided to dissolve the ten existing Round Tables as from the end of the Glasgow conference. Eight of these continued their activities as IFLA Sections:

- Continuing Professional Development and Workplace Learning (formerly Continuing Professional Education Round Table)
- Information Literacy (formerly User Education Round Table)
- Library History
- Library and Information Science Journals
- Management of Library Associations
- Mobile Libraries
- Newspapers
- Women's Issues

The Round Table of National Centres for Library Services (ROTNAC) decided to "float free"; it became a Body with Consultative Status. INTAMEL, the International Association of Metropolitan Libraries had not decided on its future format at the end of the report period, although it had lost its IFLA Round Table status.

The transfer of IFLA's website IFLANET from the National Library of Canada to INIST in France was completed early in the year. This included the transfer of a considerable number of IFLA discussion lists, which were now offered with interfaces in various different languages. The Queens Borough Library in New York (USA) came into operation as the north American mirror site for IFLANET. Sophie Felföldi, previously Office Manager at IFLA/HQ, was appointed Webmanager; she continued to be based at IFLA/HQ.

Following a recommendation by the Conference Planning Committee, the Governing Board selected Congrex Holland as IFLA's Core Professional Conference Organiser (PCO) during its March meeting. Later in the report year, a contract was concluded for the organisation of the annual congresses 2005 through 2009.

Québec and Rome were shortlisted as candidate venues for the World Library and Information Congress 2008.

A meeting of IFLA's Core Activities Directors and Regional Managers with IFLA/HQ staff was held at the headquarters office in The Hague, 16 and 17 October. Many issues of common interest, including administrative and communication matters, were discussed.

After IFLA had been represented in all of a series of 5 consultation meetings at UNESCO in Paris in February and April, the Board agreed that IFLA should be involved in the process which eventually will lead up to the World Summit on the Information Society (Geneva 2003 and Tunis 2005) and that it should also continue to work closely with UNESCO on this issue.

CORE ACTIVITIES

This year the central IFLA fund from which the Core Activities are co-financed continued to diminish; in fact it was almost exhausted. In addition we received the news that the Danish governmental development agency DANIDA, which donated considerable support during a range of previous years, had stopped its support. The IFLA/ALP and IFLA/FAIFE core activities were the programmes that were most heavily affected by this development.

The Governing Board agreed to renew the existing contract with the Bibliothèque nationale de France for the hosting and operation of the IFLA/PAC Core Activity.

There had been major staff changes at the British Library, including the retirement (in 2001) of the Director of the IFLA/UAP programme. One consequence was the closure of the UAP office which had been in operation at the British Library in Boston Spa for decades. The Board took the view that two viable and highly appreciated features deserved an extended life. The future of the biennial *IFLA Interlending and Document Delivery Conference* was commissioned to the IFLA Section of the same name.

In December the Board ruled - after having considered the result of an independent financial assessment - that running the *International Interlending Voucher Scheme* had to be taken over by IFLA Headquarters. This would come into effect in 2003.

With a view to the approaching scaling down of the IFLA/UBCIM Core Activity at Die Deutsche Bibliothek in Frankfurt, the Board agreed to transfer the UNIMARC programme to the National Library of Portugal in Lisbon. This would take effect from 2003 for a three-year period.

The definitive closure of both the IFLA/UAP and IFLA/UBCIM programmes is foreseen to take place in early 2003.

GENERAL CONFERENCE

IFLA's 68th General Conference was held at the Scottish Exhibition and Conference Centre in Glasgow, UK, 17 – 25 August 2002. Over 4,300 participants attended – approximately 1000 more than the previous IFLA

conference held in Europe (Amsterdam, August 1998). A high number of first-timer attendants (1,082) and a high number of countries represented (131) were also noteworthy.

As in other years, the host country had the largest contingent of representatives with 1,443 delegates from the United Kingdom. Runners up were the United States (549), the Russian Federation (158), France (145) and the Netherlands (140).

The exhibition brought together 126 stands from 140 companies with a total floor space of 2,385 m². More than 85 persons were able to attend, thanks to grants from DANIDA, the US Fellowship Programme, le Comité français IFLA, and various national library associations. Because of the withdrawal of funds, the DANIDA grants were supplemented from central IFLA funds. One hundred volunteers had been enrolled for the conference.

Social events included a reception at the Scottish Science Centre, a cultural evening at the Royal Concert Hall, a reception at the National Museums of Scotland in Edinburgh followed by a Tattoo at Edinburgh Castle.

The conference marked the 75th anniversary of IFLA, as it was established at Edinburgh in August 1927. In all delegates' conference bags two leaflets were distributed, one of which – "IFLA 1927-2002" – had been donated by the Dutch organisation NBD/Bibliion. The other was an historical overview by Donald Davis which was donated by the University of Texas at Austin.

A new feature of the professional programme was the "Red Thread", which was designed to bring out the conference theme, *Libraries for life: democracy, diversity, delivery*, as strong as possible. This included the plenary speakers, Seamus Heaney, Gerard Lemos and Anne Fine.

A large group of delegates – representing all regions and professional Levels - took part in a special Brainstorming session. The purpose of this special event was to help Kay Raseroka, first ever President-elect of IFLA, to prioritise the aims and actions for her period as President, due to begin in 2003.

The Governing Board decided on a new title for the IFLA Conference in future: the *World Library and Information Congress (WLIC)*. The existing name (IFLA General Conference and Council) will be retained as a subtitle. The Board reaffirmed that Buenos Aires, Argentina, would be the venue for the 2004 congress. It selected Durban, South Africa, to host the WLIC in 2007.

Some professional highlights of the Glasgow conference included the release of a joint IFLA/IPA statement entitled *Preserving the Memory of the World in Perpetuity* which commits both organisations to work together on joint initiatives to study the technical, economic and policy issues surrounding digital preservation and the approval by the Governing Board of a *Statement on Libraries and Sustainable Development*.

The *IFLA/FAIFE Summary Report 2002 – Libraries, Conflicts and the Internet* was launched. The report discusses Internet accessible information and censorship and presents an overview of the global situation relating to

libraries and information services and intellectual freedom. It introduced the topic "libraries and conflicts" and discussed some of the possibilities on how to respond when intellectual freedoms are at stake.

The Glasgow conference saw the end of the *Books for All* programme. Under its aegis - in a cooperation between the IFLA Children and Young Adults Section and UNESCO - an amount of USD 500,000 was raised during the period 1973-2002. The funds were used for donating reading materials, mainly through school libraries, to children in developing countries. The project leader 1990-2002, Ms Lioba Betten, was awarded an IFLA scroll.

At Glasgow a new set of contracts between IFLA and K.G. Saur Publishers was signed, regulating the publication of the IFLA Publications books series and *IFLA Journal*.

A total of 21 new members joined IFLA during the conference.

Six satellite meetings were organised immediately prior to the Glasgow conference.

PRIZES AND AWARDS

The Hans-Peter Geh Grant, which is normally given every year to sponsor one librarian from the former Soviet Union, including the Baltic States, to attend an IFLA Seminar or Conference was not awarded in 2002, due to a lack of suitable candidates.

With support from the Margreet Wijnstroom Fund for Regional Library Development three colleagues were assisted to attend the Glasgow Conference:

The following recipients of the IFLA/OCLC Early Career Development Fellowships (for 2003) were selected: Selenay Aytaç (Turkey), Anjali Gulati (India), Hyekyong Hwang (Korea), Ibrahim Ramjaun (Mauritius) and Thi Nha Vu (Vietnam).

The *Newsletter of the Asia and Oceania Section* was awarded Best IFLA Newsletter 2002. *Constructing the Road to Digitisation at UCT Libraries* by Kate Murray from the Department of Information and Library Studies at the University of Capetown, South Africa, was the winner of the Best IFLA Poster 2002.

IFLA STAFF AND OFFICES

Secretary General Ross Shimmon was on long-term sick leave, due to medical treatment, during a period of four months (March-June 2002) Sjoerd Koopman replaced him as Acting Secretary General.

Jos de Block retired as Secretary to the Coordinator of Professional Activities in July and Dini Verschoor retired as Financial Officer in October 2002. Both had been on the IFLA Headquarters staff for more than 20 years.

Christine Zuidwijk was appointed as Financial Officer from September.

Corinne Koch followed Virginie Kremp as Programme Officer at the IFLA/PAC Office in Paris in May.

RELATIONS WITH OTHER BODIES

UNESCO: United Nations Educational Scientific and Cultural Organisation

IFLA was represented during the first meeting of UNESCO's international Council for the Information for All Programme in March 2002.

A number of projects was executed with the support of UNESCO funding:

- Guidelines for Digitization of Materials held in Libraries and Archives (jointly with ICA)
- Preparation of new editions of existing IFLA/UNESCO publications

ICA: International Council on Archives

ICA and IFLA leadership met in the course of the reporting period in The Hague and Paris. Matters of common interest, including projects and the running of both membership organisations were discussed.

ICBS: International Committee for the Blue Shield

IFLA forms this permanent Committee together with the International Council on Archives (ICA), the International Council of Museums (ICOM) and the International Committee on Monuments and Sites (ICOMOS). During the report period three meetings were held.

The Committee decided to appoint a president to serve for a period of one year, instead of the previous arrangement whereby the chair rotated between the representatives of the four founder member organisations meeting by meeting. During the meeting on 18th November, IFLA Secretary General Ross Shimmon was appointed ICBS President for the period to the end of 2003. More information is available in the IFLA/PAC Annual Report.

IPA: International Publishers Association

IPA and IFLA maintain a joint IFLA/IPA Steering Group; Ingrid Parent, Claudia Lux, Sandy Norman and Ross Shimmon represented IFLA. During the report period the Steering Group met three times. On the agenda were various issues relating to common interests of libraries and publishers, such as the use of permanent paper by publishers, the development of joint strategies for coping with the need of visually impaired readers etc.

In the course of 2002 Sandy Norman left the group due to her retirement.
